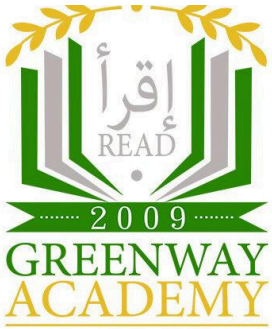


# GREENWAY ACADEMY & APESF

This tax season, redirect all or a portion of your AZ state tax liability by making a tax credit donation, which provides tuition scholarships to Greenway Academy students! ...**At no cost to you!**

Here's how it works:

## STEP 1

### MAKING YOUR DONATION

If you owe AZ state taxes, you can donate your entire state liability up to the max amount set by the state.

Greenway Academy partners with APESF, a non-profit STO, to award your generous donations as tuition scholarships. Give securely online or use the contribution form.



## STEP 2

### RECOMMEND GREENWAY ACADEMY

On the APESF donation form, you will be asked to recommend a *specific school*. Be sure to select 'Greenway Academy' from the drop down menu.

Once your donation has been submitted, you will receive an official contribution receipt by email.



## STEP 3

### TAKE YOUR STATE TAX CREDIT

When filing your tax return in the spring, make sure to document your *Private School Tax Credit* donation to ensure you get your *dollar-for-dollar* tax credit.

Tax credits are easily reported on AZ Forms 301, 323, and 348.

## HOW IT WORKS

### DETERMINE YOUR DOLLAR AMOUNT

The maximum amount you may contribute is the same as your state tax liability or the amount set by the state for your current tax year, whichever is less.

#### 2025 Maximum Allowed Credits

**\$3,062 for Married Filing Jointly**

Original: \$1,535 // Switcher: \$1,527

**\$1,535 for Single/Married Filing Separately**

Original: \$769 // Switcher: \$766

### RECOMMEND GREENWAY ACADEMY AS THE SPECIFIC SCHOOL

Although Arizona law prevents school tuition organizations from using recommendations as the only consideration when awarding scholarships, APESF does use them as one of our primary considerations.
